Receive up to \$1,000 To make your Community a Better Place

The National VFW Foundation wants to help your Post get more involved in your community. That's why they have established a "VFW Foundation Post/VFW Auxiliary Support Grant" open to VFW Posts and their Auxiliaries.

The VFW Foundation will provide up to \$1,000 to a Post and/or VFW Auxiliary supporting local nonprofits or performing an important outreach in their community or enhancements to Post buildings for this purpose!

The application process is simple:

- •A VFW Post and/or VFW Auxiliary can apply using the "VFW Foundation Post/VFW Auxiliary Community Support Grant" application available on the National VFW web site www.vfw.org. The application must be signed and authorized by the head of your organization (Post Commander or VFW Auxiliary President) so that he/she is knowledgeable and supportive of the request.
- •After the application is submitted, the applicant will receive notification from the VFW Foundation within thirty (30) calendar days of a decision. If the project has been approved, a check or notification of ACH from the VFW Foundation will be included with the decision letter.
- •A Post and/or VFW Auxiliary that receives grant funding must complete a Final Report (also provided by the VFW Foundation in the award letter) along with proof of expenditures in the

form of receipts, invoice copies or copies of check(s) that verify spending for their project.

- •VFW Foundation grant funds must be expended within nine (9) months of the award date which coincides with the time frame expected for a project completion. A report detailing how the funds were spent must be received by the VFW Foundation no later than July 1, 2017.
- •Grant funds cannot be used to promote activities that will benefit a particular religion, race or any other cause that would seek to exclude or discriminate, or to provide assistance only to members of such religion, race or group.
- •Grant funds may not be used in any capacity for canteen/bar enhancements, repairs or operation expenses.
- •Grant funds cannot be made available to any government entity or their agencies (local, state or federal) with the exception of public schools, and local law enforcement and first responder units. Grant funds can only be used for activities associated for direct outreach. Funds cannot be requested to support political viewpoints, candidates or legislative/ballot/legal issues.
- •A VFW Post and/or VFW Auxiliary can only apply once per fiscal year (VFW Foundation fiscal year begins and ends on September 1) for this grant. Only VFW Posts & VFW Auxiliaries that are in good standing are eligible to apply.

Thank you to the VFW Posts, VFW Auxiliaries, family members and friends for your donations. Every donation received makes a difference in the lives of Colorado's Veterans and their families.

We are now accepting and processing applications for Eligible Veterans and their Families in the State of Colorado. With the trends in employment and housing we anticipate the available funds will not last the full FY 2016-2017. We are anticipating the funds will be spent before the end of the year. Between August 1, 2016 through September 30, 20106 we have expended \$23,295.50 in assistance to 50 Veterans and their Families with Rent, Utilities, and Vehicle Repairs etc.... If the trend continues once the cold weather hits, we will be out of funds before the 1st of the year.

Any eligible Veteran in need of assistance across the State of Colorado can apply for a one time Grant of \$500. We receive referrals from VA Social workers, Veterans Service Officers, and other

non-profit organizations. In the event the need is greater than the assistance that can be provided, the veteran will be referred to outside resources for: additional assistance to prevent eviction/ or loss of shelter, help with employment/interviewing/resume writing. Veterans will also be referred to our Veterans Service Officers for help with VA Claims and Benefits or, to their Local Human Services Agencies for any additional state assistance as they may qualify for.

The Grant Application is available on the Department Website to download; follow the requirements and submit the application to our office.

At the 117th Veterans of Foreign Wars National Convention held in Charlotte, North Carolina in July, it was voted to remove the section of its Bylaws that allows the formation of Men's Auxiliaries. As of January 1, 2017, there will no longer be any Men's Auxiliaries. It is the hope that the men, if they are eligible, will join the VFW Auxiliary.

Many have asked about Men's Auxiliary members transferring to the VFW Auxiliary and/or why they have to show eligibility. A former Men's Auxiliary member cannot transfer to the VFW Auxiliary. They belonged to a state-run organization under their Department that was in no way affiliated with the VFW Auxiliary. According to our Bylaws, all new members (regardless of past membership in any other organization) complete an application, show proof of eligibility (unless eligibility is under a member of that Post), pay dues and be voted on. If you have any questions, please contact

Department Headquarters.

My theme this year is "What Have You Done For A Veteran, Today?". If you see someone walking down the street and they have a cap or shirt that says they are a veteran, shake their hand and thank them for their service. Also, if there is a shut-in at your post, call them and offer to take them to pick-up their drugs or run an errand for them.

I plan to attend the Council of Administration in Colorado Springs on the 19th and 20th of November and look forward to seeing you there. Let's all work together to help and support veterans!

General Orders No. 2 November 1, 2016 Series: 2016-2017

- 1. Post & District Inspections should be completed by December 31, 2016. Send all three (3) copies to Department Headquarters for the Department Inspector to review. If he finds any irregularities he will confer with the State Commander and a letter of recommendation will be written to the Post Commander.
- 2. Section 709 of the VFW National By-Laws concerns Disposition of Real Property, i.e. Post Homes. Written notice of such proposal has first to be given to each member of said unit and the Department Commander ten (10) days prior to such regular or special meeting at which the proposal is to be considered, and then only by two-thirds (2/3) vote of approval of those present and voting at such regular or special meeting.
- 3. It is the obligation of every member to GET OUT AND VOTE for the candidates of their choice. Take a friend or friends with you to the voting place. Election day is November 8th and you must be registered to exercise your right to vote.
- 4. Post Quartermaster and District Quartermaster Bonds expired August 31, 2016. Applications have been mailed to ALL Commanders for renewal. Please see that your Quartermaster is bonded in an amount equal to your Post liquid assets. This means ALL funds, Post, Club, Bingo, CD's, etc. Cost is \$4.50 per thousand. All Accountable Officers that are responsible for Post and District funds may be bonded. Bond applications and instructions are available on www. vfwcolodept.org under forms.

Bingo Managers cannot be bonded under the Accountable Officers Bond. Your Post must carry a Dishonesty Bond on them.

5. Section 218, paragraph (11), Duty of Trustees, Trustees shall not be eligible to serve on committees or as officers whose books, records and accounts are audited by the Trustees. Among the duties of the three (3) elected Post Trustees, they shall: (duties are listed a - d).

Post Commanders and Post Trustees are reminded that the 2^{nd} Post Trustee Report of Audit was due to be at Department Headquarters on October 25, 2016 to meet Âll State requirements. Please see your Post Quartermaster for forms and records.

- 6. Please be informed that any Post or District requesting a Department Officer to attend a VFW function should make such request in writing to the State Commander. Please allow sufficient time, at least three (3) weeks, for Department to make arrangements.
- 7. All VFW Posts are required to purchase the revised By-Laws and Ritual books from the VFW National Emblem

and Supply Department. Please see your Post Quartermaster and ask him to order for you. All members should be informed that the Post Quartermaster has a current supply catalog and he is instructed to assist you with your order.

8. An annual income tax return (Form 990) is required of each Post, District and Men's Auxiliary exempt from tax under section 501 (c) 19 of the Federal Code. Starting in 2008 ALL VFW POSTS, DISTRICTS and MEN's AUXILIARIES with gross receipts of \$50,000 or less have to E-FILE, EVERY YEAR. All Posts exceeding \$50,000 in gross receipts must file on Form 990 or Form 990EZ. Forms and instructions are available from www.

Gross receipts include income from all sources, including membership dues, bar or restaurant receipts, etc. Some of this may be unrelated business income, in which case filing of Form 990-T may be required.

For 2015-2016, exempt organizations that are under section 501(c) and have gross receipts greater than \$50,000 but less than \$200,000 and assets less than \$500,000, may file Form 990-EZ instead of Form 990. If an organization eligible to submit the Form 990N or file the Form 990 EZ chooses to file the Form 990, it must file a complete return.

This return must be filed on or before the 15th day of the fifth month after the end of the accounting year (November 15 for June 30 year end or May 15 for calendar year end).

Request for extension of time to file may be made by submitting form 8868, Application for Extension of Time to File. If a Post, District or Men's Auxiliary fails to file the return on or before the due date, or the extended date, a penalty of \$20 for each day the return is late (not to exceed the smaller of \$10,000 or 5% of the gross receipts of the organization for the year) may be imposed, unless the organization can show that the late filing was due to reasonable cause.

If you do not file for three (3) consecutive years your Post, District or Men's Auxiliary will lose their non-profit standing with IRS and have to re-apply for non-profit standing and pay to file the application.

9. All Posts are reminded that they are responsible for filing of State Compensation Insurance, State and Federal Unemployment, State and Federal Withholding Tax and any local employee/employer tax, if

you have one or more employees.
All units of the Veterans of Foreign
Wars in Colorado are NOT exempt from State Sales and Use Tax.

Fulfilling our Nations Promise

The Defense POW/MIA Accounting Agency (DPAA) announced that the remains of a U.S. Serviceman from World War II have been identified and was returned to his family for burial with full military honors

Navy Ensign John C. England, has been returned to Colorado Springs as he was interred August 13 next to his parents who never discovered his ultimate demise. On Dec. 7, 1941, England was assigned to the USS Oklahoma, which was moored at Ford Island, Pearl Harbor, when the ship was attacked by Japanese aircraft.

The USS Oklahoma sustained multiple torpedo hits, which caused it to quickly capsize. The attack of the ship resulted in the deaths of 429 crewmen including England.

Within 12 minutes of the attack starting, the USS Oklahoma had capsized and sank in Pearl Harbor, but Ensign England used that 12 minutes to save at least three shipmates with some reports telling that he saved five before he lost his own life in the effort. Working in the radio room, England sent the order to abandon ship. Before he left, he made three trips from


the deck to the radio room and guided at least three to the deck, reports are that he went back a fourth time, but was never seen again.

Once the family found the location of Ensign England's remains, they exhumed him and started a search on a location to inter him. Fearing the old Evergreen cemetery in Colorado Springs that was opened in 1871 to which his parents were buried were closed to new interments, they took a chance to see if they had room for Ensign England. At first their fears were confirmed, but later during the same phone call they discovered that England's parents had bought a plot and a named grave marker next to theirs for him.

August 13, 2016 Ensign England was

finally laid to rest next to his parents with full military honors. His funeral was a special end to the long journey for one of America's heroes



Membership 2016-2017

At the August COA I handed out the membership goals and awards that will be given for this year. I hope that if you attended, you picked up this handout and have shared it with your Auxiliaries. For those of you who have not had an opportunity to learn about these National goals and the awards that Department will be giving for membership, this year, I will give you an overview.

The National goals this year are different that they have been in the past. We have four quarterly goals to meet to be eligible for the monetary awards. These goals are for new annual, new life, and rejoined members. First quarter, October 31, we need 95 new or rejoined, for \$200. Second quarter, January 31 we need 65 new or rejoined for \$350. Third quarter, April 30, we need 95 new or rejoined for \$400. Fourth quarter, June 30, we need 65 new or rejoined for \$500. These numbers cannot be applied from one quarter to the next; example, if we get 110 new or rejoined the first quarter, we can only use 95 and cannot apply the remaining 15 to the next quarter! I know, we are confused by this. National is asking us for 320 new or rejoined members this year but to get the monetary awards we have to spread them out in the 95,65,95,65 numbers per quarter. National is also implementing a "Circle of Excellence." Each Department President can enter this Circle if all the criteria set forth by National are met. We are fulfilling these deadlines and should not have any problem with meeting the goals. However, if we do not reach 100% membership by June 30, even if all the other goals are met, Linda will not be able to enter the "Circle of Excellence" at the National Convention in July. We were so close to our 100% goal last year and I know we can do it this year. If we meet all the criteria for the Circle of Excellence we will receive \$1000 from National.

At the Department level we have decided to give monetary awards for membership this year. We felt with our increasing number of male Auxiliary members this would appeal to everyone. At the November COA every member who has recruited a new or rejoined member will have their name entered in the drawing. Each member recruited or rejoined by a member equals one drawing entry, so if you recruit three members your name is entered three times, if you recruit six members your name is entered six times. The more new and rejoined you sign up, the more chances you have. In November, we will draw three names for \$25 each. The remaining names will remain in the drawing hopper for the March COA. At the March COA, we will draw three names for \$25 each. Also at the March COA, any member who recruits or rejoins five or more members will have their names entered, in a separate drawing, for \$50 - two names will be drawn. At the Department Convention, in June, the Auxiliary member who recruits the most new or rejoined members throughout the year will be recognized with \$75. Also, at Department Convention, the Auxiliary who recruits or rejoins the most members throughout the year will receive \$75. In case we have a tie for either of these awards the earliest transmittal date will win determine the winner. Auxiliaries will also earn 100% plaques, again this year.

Membership Chairmen, get those dues notices sent out. Be proactive and call members, use your relief funds for elderly and needy members. We are "Keeping Veterans Close to Our Hearts" and we are going to make Colorado 100% and a proud member of the "Circle of Excellence".

Auxiliary Year – When Is It Due?

Each year there are members who have questions on how the auxiliary operates with regard to the calendar year. This can be very important to know especially if you are an annual member.

Let's start with the membership year. Annual memberships are good for a 12 month period from January 1 through December 31 each year. It doesn't matter what month you pay your dues they will expire on December 31 of the current year. In order for annual members to remain in good standing, the auxiliary begins to collect dues for the next year in July. Our hope is that all annual members will have paid their dues for the next year by January 1. This becomes especially important if you are an officer on any level of the organization. Your dues must have been paid by January 1 or you cannot remain an officer as all officers must be members in good standing. Even if you are not an officer, you must be a member in good standing to attend an Auxiliary meeting.

Another important date in the member-

ship year is June 30. Any annual member who has not paid their dues for the current year by June 30 will automatically be dropped from the membership rolls. If this happens to you, you must re-apply for membership in your auxiliary. This means you must show your eligibility again and all of your continuous years of membership are gone along with your eligibility for a cancer grant for one year. This requirement is a change and is very strictly adhered to by the National organization. Once July 1 comes, dues for the current year are no longer accepted. It is really important that you pay your dues in enough time for your auxiliary treasurer to send them to the department for me to process. If they do not reach me by the cut off there is nothing I can do to get your dues paid!

Now let's talk about Life members. Obviously, they only pay their life dues once and do not pay on an annual basis but if you are an annual member and want to convert to a life membership, the timing becomes important. As an example, if you have paid your annual dues and then decide to convert to a life membership, you will be paying for both fees in one year. There is no provision in our bylaws to give you credit for the annual dues you paid when paying your life dues. The ideal way to do this is to convert before you pay annual dues for the year.

What is the auxiliary fiscal year? The auxiliaries operate on a fiscal year which is July 1 through June 30. This fiscal year is the term of office for our elected and appointed officers and chairman. Our program reporting and financial records all correspond to the fiscal year. Please keep in mind that we do have cut off dates for reporting that are set to enable our chairman and officers to file reports in a timely manner for each year. All of our auxiliaries are responsible for filing a 990 tax return with the IRS. This is also based on the July 1 through June 30 time period for all levels.

While there are always deadlines within this calendar, I hope that this information has clarified some of the timing of our activities both in our programs and with membership. I will be glad to talk with anyone who has questions about this schedule.
