I have also received word most of the larger organizations are beginning to run out of funds. Our referral base will be slim until the FY 2020-2021 begins in July.

Band Director Sought For VFW Band

The VFW Band of Colorado is seeking a principal conductor and music director to begin in January 2020. It would be preferable for a candidate to be a veteran of any U.S. Military Band, but not required.

The VFW Band plays 8-10 performances every year, the two most notable being Memorial Day at Fort Logan National Cemetery and Founder's Day at the

Brown Palace Hotel in early December. Founded in 1888, by former Leadville mayor and later U.S. Congressman, George W. Cook, a veteran of the Grand Army of the Republic, we are the oldest organized ensemble of our kind in the state of Colorado. Known first as Cook's Drum Corps., verbal history has it, that in 1931, as the number of Civil War veterans diminished, the Veterans of Foreign Wars sought our services and the name was changed to Cooks VFW Band and Drum Corps. In 1948, when the Department of Colorado designated us as their official band, our name became The VFW Band of Colorado.

While keeping with our military band heritage, the group has a two part mission of providing a place for a veteran musician to play in a band of our type, and as time permits, to represent the Veterans of Foreign Wars by providing performances at VFW functions, local and regional parades, civic ceremonies, neighborhood activities and the like. While our repertoire includes marches, standard patriotic and armed forces pieces, we also perform other types of music that fit a concert band play list.

The Band rehearses most Monday nights from 7:15 to 8:45 at VFW Post 9644 at 2680 W Hampden Ave. A stipend is available.

There seems to be some confusion over filing a claim for the Ralph

Emerson Jack Gulden Memorial Blood/Cancer Fund reimbursement. These funds are to be to be used for out of pocket expenses for treatments of blood disorders or cancer treatments. You may apply once every 2 years with a maximum of 2 times for a grant of up to \$500. We must have receipts accompany the request. This also includes reimbursement for travel for gas for which a fuel receipt must be submitted. If you have any questions, please contact Headquarters at 303-421-1630, M-F 8am to 3pm.

Since we are beginning a new decade, it's time for Posts to clean up their rosters. Contact members you have not heard from in a while and see if they still have the same address, etc. If they are de-

ceased, we need to remove them from the rosters as soon as possible. VFW Donor Services Department sends a message of condolence to the family which always helps. The reason for doing this as soon as you can, there is nothing worse than to receive a sympathy card 6 to 12 months afterwards.

If you are member and are aware of another member moving, you need to contact a Post Officer to make the Post aware. Members have the responsibility to let the Post know their information is current. There is even a space in the Online Membership System for "snow-bird" addresses. This is something new in the last 2 years, so if you know of someone who moves south for the winter, ask them to contact their Post so they can get communications and not have mail returned.

VA Now Processing Blue Water Navy Claims

On January 1, 2020, VA began processing claims under the VFW-championed Blue Water Navy Vietnam Act of 2019. The act restores VA benefits to thousands of Blue Water Navy Vietnam veterans who had their disability benefits taken away in 2002 after arbitrary regulatory changes. It benefits veterans exposed to Agent Orange while serving along the Korean DMZ with an earlier start date to encompass the timeframe when various defoliants were tested-to September 1, 1967, instead of April 1, 1968-and expands benefits to children born with spina bifida due to a parent's exposure in Thailand, coverage that already exists for the children of Vietnam and Korean

DMZ veterans.

The Act extends the presumption of herbicide exposure, that include toxins such as Agent Orange, to Veterans who served in the offshore waters of the Republic of Vietnam during the Vietnam War.

Survivors can file claims for benefits based on the Veteran's service if the Veteran died from at least one of the 14 presumptive conditions associated with herbicides such as Agent Orange.

As a result of the new law, VA will automatically review claims that are currently in the VA review process or under appeal. Visit Blue Water Navy Veterans benefits for more information.

Brothers and Sisters,

We pray you all had a Merry Christmas and remembered what the true gift is on this holiday. May

our Lord watch over you and yours in the coming year.

I want to share something that happened in December. I was notified by Department of an 91-year-old Vietnam Veteran, an At Large member who wanted someone from the VFW to visit him at his home. I was asked to visit him and help him however I could. The only information I had was his address so the next day I went to the address and a gentleman answered the door. I introduced myself and he asked me in and to have a seat. I asked him how we could help him. He told me he was 91 years old and served in Vietnam in the early 1960's. He told me he missed WWII by two weeks. He asked me if I saw the movie "We were Soldiers". I told him I did. He said he was there with Col. Moore and Mel Gibson was the right person to be Moore. He said he was selected to go to OCS and out of over 200 selected they only commissioned about 28 because they didn't need the officers at that time. He was one of the 28 selected. I asked him at what rank he had retired, and he answered Light Colonel. He told me a great story of his career for about two and a half hours. He then told me he must be boring me, but I was not bored at all. He wanted to tell his story and I wanted to hear it. He also told me he lost his wife to cancer last year and has a son in Colorado Springs that takes him to his appointments. He didn't want anything special from the VFW. He wanted to tell someone his story. Someone to talk to that would listen. He didn't know that there are posts; he just thought there was a HQ for the VFW.

If there is one veteran like this out there, how many more are sitting alone with no one to talk to or tell their story to? Our organization is based on helping, supporting and listening to our veterans. One day this could be anyone of us. We should be taking steps to make sure that all veterans can be heard.

GENERAL ORDERS NO. 3

February 1, 2020 2019-2020 Please remind all Posts that you MUST be 100% +1 to qualify for All State. Deadline is June 30, 2020. Entry forms will be e-mailed to all that qualify.

1. As prescribed by Sec 217 & Sec 221 of the National By-Laws and Manual of Procedure, Posts having two (2) meetings a month will hold nominations at the first meeting in April with elections at the next regular in April. While Posts with only (1) one meeting a month will hold nominations in March and elections in April and that all members must be notified of such elections.

(a) The officers of each Post will consist of a Commander, Senior Vice Commander, Junior Vice Commander, Quartermaster, Adjutant, Chaplain, Judge Advocate, Surgeon and three (3) Trustees.

(b) The Post shall elect the Commander, Senior Vice Commander, Junior Vice Commander, Quartermaster, Chaplain and three trustees

(c) The Appointed officers of each Post shall consist of at least an Adjutant, Judge Advocate, Surgeon, Officer of the Day, Service Officer and Guard to be appointed as prescribed in Section 216 in

the Manual of Procedure.

2. Proof of Eligibility Requirements for Officers: All Posts, Districts and Department should be reminded of the provisions of Sec. 216(c), 316, 414(c), and 515(d) of the National By-Laws and Manual or procedure that officers, elected and appointed, shall not be installed or assume the duties of their office until such proof of eligibility has been submitted to the respective Adjutant for review.

3. Registration for the VFW National Convention: Each Post will pay, in advance, a national registration fee of twenty-five dollars (\$25) which shall entitle the Post to a packet of convention information and materials and one identified registered delegate for the National Convention. Each additional delegate attending the national convention will pay a ten dollar (\$10) delegate fee, in accordance with the requirements of Sec 222 of the National Constitution and By-Laws. Delegate fees should be sent directly to the Quartermaster General

4. Attention is directed to Sec. 213 of the National By-Laws concerning arrearages of Posts for National, Department, or District Dues, National Convention registration, poppy money, supply money or other financial obligations, or failure to have the office of Quartermaster properly bonded in accordance with Section 703 of the National By-Laws, or failure to submit properly completed quarterly Post Trustees Report of Audit or Post Election Reports. Posts that are delinquent in any of the aforementioned shall be deprived of all representation

at National Headquarters.

in County Council meetings, District, Department and National Conventions.

5. Attention of Post Commanders is directed to Sec. 218, Manual of Procedure, Duty of Trustees. Trustees Report of Audit must be completed by the Trustees, in detail, at the close of each quarter, one of which ends March 31st. Commanders are reminded that all funds are to be under the custody and control of the Post Quartermaster. Persons other than the Post Quartermaster who may handle Post funds, such as club manager, bingo chairman, or committee chairmen are responsible to the Post Quartermaster to maintain accurate records and accounts and should be properly bonded. Post Trustees are to ensure that the financial records of these special funds are also audited in the same manner as the other accounts of the Post Quartermaster.

6. Commanders on all levels should begin organizing their 2020 Memorial Day Buddy Poppy Campaign. To qualify for Post All American, VFW Posts must increase their Post's Buddy Poppy purchase by 20% over the previous year from Department Headquarters.

7. All-State Commanders and Quartermasters. Entry forms for All-State Commanders and Quartermasters will be e-mailed to all qualified persons by July 1, 2020. Posts and Districts must be 100% + 1 in membership by June **30, 2020**, in order for the Commanders and/or Quartermasters to be eligible for this award and must be eligible for the Centennial Team of Post and District Commanders. The entry form, must be submitted to State Headquarters by suspense date provided in notification letter. Post Quartermasters need only submit the entry form by the same suspense date. All State Teams will be presented at the August 2020 COA meeting at Joint Opening.

8. Council of Administration meeting

will be March 15, 2020 at VFW Post 1247, Grand Junction, 8:30 am for Joint Meeting. Workshops will begin March

State Convention Buddy Poppy Display Contest

A Buddy Poppy Display Contest will again be held in connection with the State Convention. Rules have been designed to put emphasis on the purpose and effectiveness of the displays.

(1). Displays will be presented and judged in three categories: CATEGORY 1 Public Promotion of Poppy Campaign.

(Window, booth, parade, poster displays, campaign promotions, etc.)

(a). Displays must be designed for public exposure and must bear a message soliciting a donation for and wearing of the VFW Buddy Poppy

(b). At least one Poppy used in the display must be in its original form and color, with label attached.

CATEGORY 2 Memorial or Inspirational Displays

(Wreaths, memorial tablets or plaques, patriotic or devotional themes)
(a). Displays must be designed to honor the dead, to inspire devotion to God and Country,

or to dramatize the activities supported by the Buddy Poppy.
(b). At least one Poppy used in the display must be in its original form and color, with label attached.

CATEGORY 3 Artistic or Decorative Use of Poppies

(Post Home displays, table centerpieces, corsages, pictures, plaques, models, scenes, hats, novelty pieces, etc.)

(a). Any display not meeting the qualifications for Categories 1 or 2 shall automatically be entered in Category 3.

(b). At least one Poppy used in the display must be in its original form and color, with label attached.

The State Buddy Poppy Committee shall have no responsibility in setting up, taking down, or returning displays. Displays may be entered and set up at any time from 7:30 a.m. Thursday June 16.

Displays shall be set up in space provided in the Convention exhibit or meeting halls. At the time the display is set up, the responsible person must complete an entry form which will show the category of competition, the number of Poppies used, the purpose of the display, the use to which it has been put and plans for future use, the Post and/ or Auxiliary number and location, and the name of the person who will dismantle and remove the display at the close of the Convention.

Displays may be accompanied by a white card, not to exceed 4 inches by 6 inches in size, on which is lettered in black ink an explanation of the theme for the display or other information of interest to the viewer or the judges. Post name, number or location may not be visible on display entries; failure to comply will result in disqualification

Judging of displays will be on the basis of effectiveness, purpose, clarity of theme, suitability, originality, beauty and number of Poppies used. Where a sample of a large number of identical items (such as corsages or wreaths) is entered, full credit shall be given for the total number of Poppies used.

Plaques will be awarded to the first, second, and third place winners in each of the three categories. Plaques will be awarded at the Military Banquet when the winners are

First Place Winners in each Category

First Place winners in each category will be eligible to be taken to National Convention and be entered in their respective category. Entry forms must be signed by the Department Adjutant. If someone from your Post or Auxiliary is not taking the entry to National Convention, you must designate someone to be responsible to set up and take down the

display at National Convention.

SPECIAL NOTE: Departments purchasing over 250,000 Poppies will be allowed two displays in each of the three categories for the National Display Contest. All others will be allowed one display in each of the three categories.

Membership 2019 - 2020

Comrades,

We are more than halfway through our fiscal year and membership is looking good; however, we still have a long way to go. We need to ensure that our Districts, Posts, and members continue to work hard towards membership. We are above 90% in membership, but still need almost 1,500 renewals, reinstates, and recruits to reach 100%+1. We did it last year, and I know we can do it again.

Currently, there are almost 10 Posts who have reached 100% and 10 Districts who are above 90%, with many of the others trailing close behind. We have also gained over 300 new members and 30 reinstates; this shows we have been doing good, but we need to work harder. Of the over 330 new and reinstated members, there are only 119 recruiters which is only 0.77% of our membership. We can do much better than this as Colorado has a very large Military and Veteran population. We must reach out to the Military and Veterans in our communities and let them know what we do; we need to let them know they have a family in the VFW.

One of the biggest difficulties with membership in the VFW is retention; we are currently close to 1,500 members behind what we were at the end of the last fiscal year. We have been losing members for many reasons including issues

with the Post or canteen, lack of money or time, and they lack a purpose and don't see the point, or we lose track of them because their contact information is outdated. Whatever their reason to leave us is, give them a reason to stay; mentor these members and give them a sense of purpose, treat Post & Auxiliary members with dignity and respect, and help them pay their dues if they need help. If they don't have the time, let them know they do not need to be an active member to make a difference.

There are a lot of components to the success of the VFW, but membership is crucial. Without our members, our organization cannot advance or continue to care for Veterans, our Military, and their orphans and widows. It is because of our membership that the slogan "No One Does More for Veterans" continues to ring true. There have been a multitude of other Veteran Service Organizations (VSOs) that were created over the years, but the Veterans of Foreign Wars is the oldest, largest, and strongest. Please renew your dues, recruit, update your contact information, and help take care of our members so that the VFW can continue to thrive as our nation's strongest VSO. Let's "Dare to Care" and make this another successful year!

Military retirees under the age of 55 to pay reduced income taxes

Military retirees younger than 55 and living in Colorado will enjoy their first military retirement pay exemption when they file their 2019 tax year income taxes.

Colorado House Bill (HB18-1060) created a phased-in, partial tax exemption for military retirement benefits for those under the age of 55. The 2019 Tax Year specifies a state income tax exemption of \$4,500 in military retirement pay. With the existing Colorado income tax rate of 4.36%, most of our youngest military retirees will enjoy up to \$203 in lower state income taxes for 2019.

Assuming the tax rate stays stable, the phase-in exemption gradually increases as follows:
•Tax Year 2020: \$7,000 (up to \$324 tax reduction per military retiree)
•Tax Year 2021: \$10K (up to \$463 tax reduction per military retiree)
•Tax Year 2022: \$15K (up to \$695 tax reduction per military retiree).

This income tax exemption sunsets after five years, so there is a need to renew or make permanent before Tax Year 2024.

To file for the exemption, military retirees will use lines 5 and 6 on Form DR 0104AD, the schedule for handling subtractions for income for individuals. Instructions in the individual in-

come tax booklet will explain how to take the subtraction, according to Josh Pens, Director of Colorado's Office of Tax Policy Analysis. Why is the military retirement pay tax exemption only available for under 55? Colorado has an existing retirement pay (including social security) income tax exemption for all persons - civilian or military - aged 55 and over. An analysis of Colorado's military retirees showed declining numbers in younger than 55 military retirees, increasing numbers in military retirees over 55. To minimize the fiscal impact on the State's General Fund, the United Veterans Coalition of Colorado advocated for a bill that targeted under age 55 retirees and showed where this age group - second careers, working spouses, etc. brings an almost 500% return-on-investment in state and local taxes and fees. A copy of the inspection report to be sent to the Department Chief of Staff, Department Secretary and District President Councilor. District Officer making the visit should sign the Secretary and Treasurer books to verify that they are being kept in accordance with procedures. Copies of bonds, audits and verification of 990 filings should be available for review. All questions on the visit form should be completed.
