National Representative to the **100th Department Anniversary Convention** Past Commander-in-Chief John E. Hamilton

John E. Hamilton was elected Commander-in-Chief of the Veterans of Foreign Wars on July 25, 2012, at the 113th VFW National Convention in Reno, Nev.

In July 2013 he was appointed Adjutant General of the Veterans of Foreign Wars, a position he held until his retirement in 2016.

John served in the U.S. Marine Corps from 1968 to 1970, including a tour in Vietnam. His decorations include three Purple Hearts, Combat Action Ribbon, National Defense Service Medal, Vietnam Service Medal with two Bronze Stars, Republic of Vietnam Meritorious Unit Citation Gallantry Cross Color, Republic of Vietnam Unit Citation Civil Actions Color (First Class) and the Republic of Vietnam Campaign Medal.

He joined the VFW in 1974 at Post 7909 in Jacksonville, Fla., where he maintains his Gold Legacy Life member-ship. He has served the VFW in many leadership positions, including the National Council of Administration from 1989 to 1991, and as Florida's Department Commander from 1987 to 1988. He served on the board of the VFW National Home from 2002 to 2008 and as its president from 2004 to 2005. He also served as Supreme Commander of the Military Order of the Cootie from 1992 to 1993.

John graduated with honors from Georgia Military Academy



in 1967. He worked as a professional wrestler throughout the United States and the world for 15 years as Johnny Montana (also known as Dr. Death"), along with other names and identities.

He was named Florida's Young Veteran of the Year in 1981. John served as a commissioner on the United States World War I Centennial Commission board located in Washington, D.C., from 2014 to 2016, and served on the board of the World War I Museum located in Kansas City, Mo., from 2011 to 2016. He has been honored by Presidents Jimmy Carter and George H. W. Bush for his outstanding community service and leadership.

John is a member of the Military Order of the Cootic, Military Order of the Purple Heart, Disabled American Veterans, American Legion, AMVETS, Fleet Reserve Association, and the Semper Fidelis Society.

He resides in Crestview, Fla.

National Council Member Report



The National Council of Administration meet virtually over Zoom on 4-6 March 20, 2021, here are some highlights. The National Organization is in very good shape financially with a \$2 million operating budget surplus and am increase of \$11.6 million in unrestricted cash and long-term investments since August 31^{st} . Expenses have been reduced by over \$300,000 and salaries and benefits will be under budget by more than \$1.3 million. Overall, it is currently estimated that the savings in reduced expenses could be more than \$2 million.

The National organization has also experienced a great response in their fundraising appeals with a projected 256,000 new doners and 201,000 reactivated lapsed doners along with reduce cost to acquire new doners and an increase of average gifts by 35%. The calendar appeal netted over \$1 million for the first time. On the flip side COVID has had a significant negative impact in Buddy Poppy and VFW Store sales with reduction in gross sales of \$950,000.

There were two items concerning salaries. First was the adoption of a standard pay rates for the top employees. This measure provides a standard, industry method of determining salary ranges and did not result in any pay raises. Future raises will be tied to the social security cola increases and eliminates programed merit raises. The second pertained to salaries for the top three officers, Commander in Chief, Sr Vice Commander in Chief and Jr Vice Commander in Chief. Both motions carried.

There was also a motion to shift the Voice of Democracy national program from DC to the national convention and Freedom Foundation. The top 5 contestants would be escorted onto the stage by their Department Commander during the convention joint opening session. This motion did not carry due to concerns that it would impact the ability of the Department Commanders to attend the Legislative Conference.

From the Board of Directors: We hope everyone is staying safe and healthy. Our Thanks to you our Members, Family and Friends for your contributions. We are still processing grant applications and helping our members and Colorado's Veterans and their families.

Our office still has funding to help veterans in need. We have not received the applications that we normally receivewe have processed 40 grants- approved 32 and declined 8 (incomplete/situation changed), expending \$17,498.28 in assistance. We have also been talking to our referral sources and they have report-

ed a slowness in requests for assistance. If you know of a veteran in need of assistance please call our office. We try to make the process as painless as possible and as timely as possible.

The Grant Application is available on the Department Website. Any eligible Veteran in need of emergency assistance across the State of Colorado can apply for a one time Grant of up to \$500.


Only the World War II Veterans that win will be allowed to board the biplane, Dream Flights never charges veterans, their families, or the communities where they live for Dream Flights.

General Orders No. 4 May 1, 2021 Series 2020-2021

1. **100th DEPARTMENT ANNIVERSARY CONVENTION** will be held in the Double Tree Hotel, 3203 Quebec, Denver, CO., June 9th through 12th, hosted by Department of Colorado VFW, Lakewood, CO. The Council of Administration will meet at 6:00 pm, June 9^{th...} All Council Members are requested to attend!! Uniform for the Convention will be: Council of Administration - casual; Joint Opening - Blues & Greys; Business Sessions -Black & White; Joint Memorial - Dark Suit or Blues & Greys.

2. **POST QUARTERMASTERS**: Request the assistance of your members in completing the list of deceased members form and return to Department Headquarters no later than May 20, 2021.

3. **DISTRICT COMMANDERS** must attend Council of Administration meeting June 9th at State Convention in Denver, CO. You must also be present at ALL Business Sessions to receive your full travel expense check plus per diem for you motel room.

4. **POST ELECTION REPORTS**: It is the responsibility of the membership to insist that the responsible officer reports the elections of officers to Department immediately after the election is completed. If not sent to Department Headquarters by June 1, 2021, your Post will not be allowed to vote at State Convention.

Section 213 – Arrearages, Deficiencies and Omissions states: Any Post in arrears for any financial obligations to District, Department or National for fees, dues, poppy money, supply money, failing to have the office of Quartermaster properly bonded in accordance with Section 703, failing to ensure that the Post is properly insured in accordance with Section 709, failing to submit properly completed quarterly Post Trustees Report of Audit, Post Election Report for the ensuing year, or other obligations, shall be deprived of all representation in District, Department and National Conventions. Such representation shall be restored promptly upon proper adjustment of such deficiencies.

5. POST AND DISTRICT ELECTION REPORTS: If not sent to Department by July 1, 2021 your officers will be omitted from the Department Roster. No exceptions.

6. **POSTS SHOULD ARRANGE SPECIAL CEREMONIES** and all Commanders shall alert comrades to their obligations for appropriate commemoration of the following outstanding action dates in U.S. History: May 8th, VE Day; June 6th, D Day; June 14th, Flag Day. It is requested that all Posts and their members honor Memorial Day on May 31st.

7. **DELEGATE FEE NOTICES** are being sent to each Post Quartermaster. Fee must be paid to Department Headquarters prior to State Convention or your vote will not be accepted. Post Commander Delegate Card will be mailed to the Post Commander.

Membership 2020 - 2021

At the time of writing this article District #11 has achieved their goal of 100%+1 and I hope to see many more raise to the 100% level. There are 4 Districts that are needing 10 member or less to achieved 100% also. Great job remember that the membership year ends June 30, 2021.

At the Post level there are 16 Post have achieved their goal of 100%+1. A Thanks for a job well done. There are still 58 Post that are needing 10 or less to make a 100%+1. With that being said you are so close let's put the final push within your Post to join the other Post that have achieved 100%+1 within Colorado.

Right now, the Department of Colorado is at 95.95% for membership. We currently have 14591 paid members. That is 673 below last years high. We are 177 members lower than this time last year. We need to sign up 8.85 members per day to reach 100% of last years membership. Interesting enough, we have 902 unpaid members from the last two years plus we have another 710-member expiring this VFW year.

The Quartermaster has access to your Post unpaid list. With not a lot of interaction with member this year due to the COVID-19 we need to work extra on reaching out to are membership. Quartermasters get your lists to the Post Commanders so that they can work their unpaid membership. We have their addresses and phone numbers at our fingertips. Give them a call. They may not have renewed their dues because they might need a little help.

might need a little help. Just let everyone know that per MOP Sec 209 (g) Post Relief fund can be used for the remission of dues of sick, needy or disabled members. I know that every Post must have a Relief fund. I realize not every Post can help pay for 5 or 10 members who may need help, but I also know some Posts can, just help your fellow Comrades in needy times. So, I'm asking every Post to look through your records and give an unpaid member a call and see how they are doing. You never know, you could be helping with more than membership.

What the math tells me if we work the Post unpaid list, we should be able to have all the Post within the Department at 100%. I know we must consider members passing. Members moving away. But I think that falls into statistical range of losing 10% of your membership to situations we can't control.

cine/ There is also a provision in the American Rescue Plan that waives all co-pays for VA healthcare between April 6, 2020 through September 30, 2021. If you have copayments that were suspended when the pandemic began, they are now forgiven. If you've made payments already you can expect a refund!

I also want to share information I recently received on a VA approved PTSD treatment that is available through the

Community Care Program. A representative from TMS Solutions (<u>https://www.</u> <u>tmssolutions.com</u>) attended the April Post 1 membership meeting and, to me, Transcranial Magnetic Stimulation seem promising. It is a non-invasive, outpatient therapy that uses MRI strength magnets to provide relief from PTSD, depression and anxiety. If medication and talk therapy haven't helped, this could be a new avenue for you or a comrade who is still suffering. If you are interested, ask your VA provider for a Community Care referral.

Lastly, I want to say "thank you" for letting me serve as you Surgeon for the past year. While I wasn't able to travel the State and visit our comrades at the Community Living Centers, I hope our next surgeon will allow me to tag along sometimes when the CLCs reopen.

State Convention Buddy Poppy Display Contest

A Buddy Poppy Display Contest will again be held in connection with the State Convention. Rules have been designed to put emphasis on the purpose and effectiveness of the displays. rules

(1). Displays will be presented and judged in three categories:

CATEGORY 1 Public Promotion of Poppy Campaign.

Examples (Window, booth, parade, poster displays, campaign promotions, etc.) (a). Displays must be designed for public exposure and must bear a message soliciting

a donation for and wearing of the VFW Buddy Poppy

(b). At least one Poppy used in the display must be in its original form and color, with label attached.

CATEGORY 2 Memorial or Inspirational Displays

Examples (Wreaths, memorial tablets or plaques, patriotic or devotional themes)

(a). Displays must be designed to honor the dead, to inspire devotion to God and Country,

or to dramatize the activities supported by the Buddy Poppy. (b). At least one Poppy used in the display must be in its original form and color, with label attached.

CATEGORY 3 Artistic or Decorative Use of Poppies

Examples (Post Home displays, table centerpieces, corsages, pictures, plaques, models, scenes, hats, novelty pieces, etc.)

(a). Any display not meeting the qualifications for Categories 1 or 2 shall automatically be entered in Category 3.

(b). At least one Poppy used in the display must be in its original form and color, with label attached.

The State Buddy Poppy Committee shall have no responsibility in setting up, taking down, or returning displays. Displays may be entered and set up at any time from 7:30 AM to 5 PM Thursday June 10 and from 8:00 AM thru Noon Friday.

Displays shall be set up in space provided in the Convention exhibit room. At the time the display is set up, the responsible person must complete an entry form which will show the category of competition, the number of Poppies used, the purpose of the display, the use to which it has been put and plans for future use, the Post and/or Auxiliary number and location, and the name and cell number of the person who will dismantle and remove the display at the close of the Convention.

Displays may be accompanied by a white card, not to exceed 4 inches by 6 inches in size, on which is lettered in black ink an explanation of the theme for the display or other information of interest to the viewer or the judges. <u>Post name, number or location may</u> not be visible on display entries; failure to comply will result in disqualification. judging

Judging of displays will be on the basis of effectiveness, purpose, clarity of theme, suitability, originality, beauty and number of Poppies used. Where a sample of a large number of identical items (such as corsages or wreaths) is entered, full credit shall be given for the total number of Poppies used. prizes

Plaques will be awarded to the first, second, and third place winners in each of the three categories. Plaques will be awarded at the Friday Night Banquet when the winners are announced.

First Place Winners in each Category

First Place winners in each category will be eligible to be taken to National Convention and be entered in their respective category. Entry forms must be signed by the Department Adjutant. If someone from your Post or Auxiliary is not taking the entry to National Convention, you must designate someone to be responsible to set up and take down the display at National Convention.

SPECIAL NOTE:

Buddy Poppy Hat Parade, due to time restraints this year, is canceled, hopefully at the 2022 State Convention it will be back.

Let us all remember the long history of the Buddy Poppy, what the donations help fund, and learn the history of the Poppy so we can spread the word.
