# Membership

#### NEW/REINSTATED MEMBERSHIP GRANT INITIATIVE FOR VFW POSTS

As of Jan. 1, 2022, every VFW Post that signs up and submits full membership dues\* for each member will receive a grant based on the type of membership submitted while funds are available.

- Full membership dues include the per capita for National, Department and the Post.
- Reinstated definition Anyone that has been a member before, and their dues have been expired for two years and one day or more is classified as a Reinstated member.
- Members submitted prior to Jan. 1 are not eligible for this program.
- Current Annual members defined as any member whose dues have not been expired more than two years are not eligible for the grant.
- Members at Large are not part of this program.

## 2022 KANSAS CITY SPREE

The top two Post Commanders and the top two District Commanders in each division who achieve 100 percent membership by April 1, 2022, along with their guest will each be awarded:

- Round-trip airfare to Kansas City, MO, from the airport nearest the awardee's home.

## **DEPARTMENT "100 PERCENT" INCENTIVE**

# VFW Programs

**DISPLAYING MILITARY SERVICE SYMBOLS.** Military service flags, insignias, etc. should be displayed in the following order (left to right as you face the flags): Army, Marine Corps, Navy, Air Force, Space Force and then Coast Guard. For military flags, go to <u>vfwstore.org/searchresults?q=MilitaryFlag</u>.

**2022 VIRTUAL VOICE OF DEMOCRACY – PARADE OF WINNERS.** The Parade of Winners awards ceremony will be on Thursday, April 7, at 7 p.m. The ceremony will be streamed live on the VFW Facebook page, <u>facebook.com/events/634012827708404</u>.

**NOTE: SMART/MAHER VFW NATIONAL CITIZENSHIP EDUCATION TEACHER AWARD.** The National Teacher Award judging has been completed and the winner will be announced during the Virtual Voice of Democracy-Parade of Winners awards ceremony on Thursday, April 7, at 7 p.m.

**ALL-AMERICAN DASHBOARD.** Military Assistance Program grants have been launched to show Departments and Posts how much in grant assistance that has been received from National HQs to supplement the Unmet Needs financial grants and VFW Sport Clips Help-A-Hero scholarship statistics. The information charts reside on the KPI tools section.

Please encourage Posts to read the 2021-22 Membership program. Many Posts don't understand they need to sign up five new Action Corps subscribers, create a Facebook page, two separate partnering events along with a 10% increase in Community Service Impact from last year. They must submit reports through the dashboard to gain credit.

**NATIONAL COMMUNITY SERVICE VOLUNTEER RECOGNITION PROGRAM.** This program is designed to provide recognition and awards to VFW members who volunteer their time to outside organizations. Recognition is in the form of certificates and/or lapel pins which are given to volunteers who have completed the number of hours prescribed for those awards. **HALF-STAFF U.S. FLAG.** The U.S. Flag should be at half-staff on Memorial Day, the last Monday in May (federal holiday - half-staff until noon). Flags available at VFW Store <u>vfwstore.org/category/flags/usflags</u>.

**VFW SPECIAL PROJECT PROGRAM.** This program was put in place to recognize VFW units for creating and completing unique and extraordinary community service projects.

Record book entry nominations that are found to be complete and well-substantiated should be endorsed by the Department Adjutant or VFW Department Community Activities Chairman and forwarded to National Programs Department. Deadline for entries is April 30 of each year.

Every Post Special Project receiving the Award of Excellence in the May judging will be entered in the Fred C. Hall Memorial Outstanding Post Special Project Competition. Complete information can be found in the VFW Community Activities and Citizenship Education Chairman's Manual.

**FLAG DAY, JUNE 14.** All VFW units are reminded to properly display the U.S. Flag on Flag Day, Tuesday, June 14 and to conduct a ceremony or program as feasible. You may contact the VFW Communications Department for a Flag Day speech. It is also suggested Posts should award the VFW Patriotic Citizen Award (Product No. 4385) for those who have daily displayed our National flag.

**"UPDATED" POW/MIA FLAG -- OFFICIAL DISPLAY DAYS.** Under previous Public Law 105-85 (Nov. 16, 1997) it indicated there were only six days that federal agencies, military installations and U.S. post offices were required to display the POW/MIA flag. Now under new law, Public Law 116-67 (Feb. 21, 2020), it is required that the POW/MIA flag be flown on all days on which the flag of the United States is displayed. To purchase a POW/MIA flag, go to vfwstore.org/products/GP237.

**IRS AND VFW AWARD MONIES.** The Internal Revenue Service (IRS) requires that any recipient that receives more than a \$599 award should receive a Form 1099 identifying the proceeds as taxable. This will include the VFW programs Patriot's Pen and Smart/Maher VFW National Citizenship Education Teacher Award.

# "Buddy"<sup>®</sup> Poppy

**"BUDDY"** <sup>®</sup> **POPPY CAMPAIGN.** Although we emphasize Buddy Poppies on Veterans Day and Memorial Day, it is important to realize that the distribution of Buddy Poppies should be a year-round exercise. Each time a Post participates in an activity where the public will be present, Buddy Poppies should be present as a fundraising tool and simply to recognize our fallen comrades. Where the VFW appears, Buddy Poppies should be a constant reminder that we will never forget those who have perished in the name of liberty. Just as "They Gave, Will You?" is a year-round thing, so should the distribution of VFW Buddy Poppies.

Remember that your poppies should be ordered a minimum of 8 weeks in advance of your distribution date. Be sure to specify a date by which the poppies are required, do not use "ASAP."

BUDDY POPPY UPDATE: National Headquarters conducted a review of the Buddy Poppy policy and procedures and implemented the following changes effective May 20, 2021:

- 1) If you do not receive your order within 8 weeks of placing it with your Department, please contact National Headquarters to report that you have not received the order.
- 2) If you do not report a missing order 3 months after the 8-week processing time, the order will NOT be replaced free of charge and you will have to resubmit your order.

Miscellaneous items (coin cans, buttons, posters, etc.) should be ordered directly from the VFW Store at <u>vfwstore.org/category/programs/buddypoppy</u> or the VFW Store/Emblem and Supply Catalog.

The Manual of Procedure provides that Post relief funds may be used for programs such as Voice of Democracy, Patriot's Pen, Citizenship Education, and Community Service as long as suggestions in the chairmen guidebooks are used as an example of promoting these programs.

Posts are further reminded that Section 711 of the Manual of Procedure provides that non-profit organizations, exempt from taxes under Section 501(a) of the Internal Revenue Code, may assist with the distribution of Buddy Poppies, provided there shall be no division of proceeds. A donation to these groups may be made from the Post general fund.

**NATIONAL "BUDDY"** <sup>®</sup> **POPPY DISPLAY CONTEST.** The time frame for registering and setting up the Department winning Buddy Poppy displays for the national judging at convention will be the same as usual. Department winning entries will be accepted for registration and may be set up beginning at 8:00 a.m., Saturday, July 16, until noon, Monday, July 18, 2022. Winning displays will be identified with appropriate ribbons on Tuesday morning and announced later on the convention floor. Displays must be removed prior to 11:30 a.m. on Wednesday afternoon. Any displays left after this time will be removed for disposal by Convention center personnel during the disassembly of the hall.

**VFW SILVER, GOLD AND DIAMOND ANNIVERSARY POPPIES.** The silver, gold and diamond anniversary Buddy Poppies are for Posts that are currently in their 25th, 50th or 75th anniversary years. For Posts currently in their 100th year anniversary, they can order any color and as many as they need. The anniversary poppies are approximately three times as expensive for us to produce, but because of the small quantities we deal in, we don't pass those costs on to the Posts. Please limit your order of anniversary poppies to 1,000 to ensure stock does not run out, unless you are currently in your 100th year. These are ordered through the Department and processed the same as the red poppies. Annotate on the order to National that it is for anniversary poppies and specify which one.

# **Quartermaster General**

At a meeting on Feb. 28, 2022, the Life Membership Board of Trustees recommended, and the National Council of Administration approved the following 2022-23 Life member payout.

- Plan ABC A total payout of \$10.50 for each Life member (\$3.50 to each Post, Department and National).
- Plan D A total payout of \$16.50 for each Life member (\$5.50 to each Post, Department and National).
- Plan E A total payout of \$27.00 for each Life member (\$9.00 to each Post, Department and National).

As indicated in the Bylaws, payment will be made in Sept. 2022 for all Life members recorded as of Aug. 31, 2022. In addition, a payment will be made in Jan. 2023 for all Life members processed during the period Sept. 1 through Dec. 31 (Plan E) to their Post, Department and to National Headquarters.

# National Veterans Service



## ACCREDITED SERVICE OFFICER TRAINING IS BEING OFFERED LIVE & VIRTUALLY

The VFW National Veterans Service is pleased to announce the upcoming VFW National Veterans Service Proficiency Training Conference (PTC) for accredited representatives is being held May 10-13, 2022, live and in-person at the Westin Riverwalk in San Antonio, Texas. Additionally, *for the first time*, we are introducing a virtual workgroup option to our live conference. This allows each Department to enroll two additional accredited representatives to attend the conference virtually at the same dates and time as live training.

There is also the potential for some limited availability for attendance by other VFW-accredited service officers. However, their attendance is conditional; they must provide their own funding and are subject to space availability, for either the live or virtual session. Additional attendees will be required to pay a \$350 registration fee for attendance at the live session or \$200 for attendance at the virtual session.

In accordance with the National Veterans Service Policy & Procedure, all VFW-accredited service officers must regularly attend National Veterans Service (NVS) training conferences, therefore, attendance at this training session is mandatory for each Department Service Officer (DSO) located in a VA Regional Office and one other VA-accredited VFW representative selected by the DSO. NVS will work with the State Department or Division of Veterans Affairs in those Departments where the state runs the service program to discuss who should attend.

#### LAST CALL FOR VFW SERVICE OFFICER OF THE YEAR 2021-22 NOMINATIONS

The deadline for submitting nominations for the John A. Biedrzycki Accredited Service Representative of the Year Award for 2021-22 is <u>April 30, 2022.</u>

Each Department Commander may nominate one eligible individual for this award. The individual who is ultimately chosen as the recipient of the award will be furnished round-trip travel (for the winner and one guest) and two night's hotel accommodations to attend the VFW National Convention (if an in-person event is held) where the award will be presented. In addition, the award recipient will receive \$599 in recognition of their accomplishments and to offset travel expenses.

We encourage every Department to put forth a candidate. A nomination shows that Department leadership is aware of the significant contributions service representatives make in your community.

#### ELIGIBILITY:

Eligible nominees include:

- Department Service Officers
- Assistant Department Service Officers
- Claims Consultants/Representative/Analysts/Reviewers
- Veterans Service Officers/Representatives

Individuals NOT eligible for this award are:

- VFW National Staff
- VFW Contractors
- VFW accredited representatives whose primary employer is other than the VFW or a State Veterans Agency
- Previous Winners of the Accredited Representative of the Year Award

#### SELECTION CRITERIA:

1. Nominees for the annual award must have demonstrated exceptional efforts in assisting veterans and their families during the 12 months preceding the April 30 deadline.

2. A brief summary (no more than 2 pages) is to be submitted which explains the who, what, when, where, and how the nominee's efforts are considered exemplary. Suggested items for consideration (but not limited to)

- Number of individuals with VFW POAs assisted
- Community outreach conducted
- Examples of excellent customer service provided
- Meticulous use of VetraSpec or another electronic claims processing system (specify system)
- Submission of TIMELY monthly reports (if located in a VA regional office)
- Number of VFW members recruited
- Innovative methods of assistance provided during the COVID-19 pandemic

# National Legislative Service/Action Corps

#### **Legislative Roundup**

The House and Senate passed a government funding omnibus package that includes 12 appropriations bills for fiscal year 2022, supplemental funding to support Ukraine, and three VFW-supported provisions that would affect veterans. The first provision would increase the maximum rate of basic pay for VA nurses and physician assistants, allowing VA to offer more competitive salaries. The second provision would permit VA's National Cemetery Administration to grant individual states the ability to decide who is interred in their state veterans cemeteries and to open their application process, ensuring all National Guard and Reserve members can be buried with fellow service members. The third provision would increase funding for VET TEC from \$45 million to \$125 million to meet the high demand for the program and enable its operation through the end of the fiscal year.

## VFW-SVA Fellowship Mock Hearing

House Veterans' Affairs Committee Ranking Member Mike Bost (R-III.) held a mock hearing with this year's VFW-SVA Legislative Fellows. Each fellow had the opportunity to testify on their proposal and answer questions. Topics included work-study parity, preventing toxic exposure, ensuring non-VA health care provider awareness of veterans, VA health care services, and extending the Forever GI Bill to include all veterans who left service after Dec. 2001.

# **General Orders No. 9**

2021-22 Series

1. Installing officers are directed to see to it that the Post Election Report forms have been completed and submitted to National Headquarters. If a Post Election Report form has not been forwarded to National Headquarters at the time of installation, the installing officer shall complete and forward such report at the time of the installation of Post Officers no later than June 1. We encourage all Post Quartermasters to use the online Election Report process featured in the Online Membership System (OMS). Post Election Reports received electronically will be forwarded to the Department Headquarters. Additionally, Section 413 of the National Bylaws requires that a properly completed District Election Report be submitted to National Headquarters prior to the convening of the Department Convention.

2. Post, District, Department Commanders, Adjutants and Quartermasters are reminded of the requirements of Sections 216, 416 and 516 of the Manual of Procedure with regard to proof of eligibility for all newly-elected and appointed officers. Elected and appointed officers shall not be installed or assume the duties of their office until proof of eligibility has been submitted and properly reviewed. Failure or refusal to submit proof of eligibility within thirty (30) days of election or appointment shall result in the office being declared vacant.

3. Department Adjutants will forward a complete roster of the newly elected and appointed Department Officers to include District Commanders to the Adjutant General immediately following their installation at the Department Convention.

4. Attention is directed to Section 518 of the Manual of Procedure, "Duty of the Department Quartermaster" paragraph (j) Budget, which states: "Prepare a tentative balanced budget for the financial operations of the ensuing year. The budget once adopted by the Department Council of Administration shall be forwarded to the Adjutant General by Nov. 1."

5. Attention is called to the provisions of Section 703 of the National Bylaws which require that each officer accountable for funds or property pursuant to any provision of these Bylaws shall be bonded with an indemnity company as surety in a sum at least equal to the amount of the liquid assets for which, so far as can be anticipated, they may be accountable. The bond premium shall be paid from the funds of the Veterans of Foreign Wars of the United States, Department, District, County Council or Post, as the case may be, to which each officer is accountable. The bonds of such accountable officers, in amount and as to surety, shall be approved by their respective units and held by their respective Commanders. The Commander of each unit shall be responsible for the proper and adequate bonding of all accountable officers in their unit.

6. Section 218 of the Manual of Procedure requires that the Post Commander shall see that the Post Trustees Reports of Audit are properly prepared and submitted each quarter.

7. Attention of incoming Post Officers is directed to Section 218 of the Manual of Procedure which outlines the duties of various Post Officers.

8. Attention is directed to the provision of Section 222 (d) of the National Bylaws, "Each Post will pay, in advance, a National Convention registration fee of twenty-five dollars (\$25) which shall entitle the Post to a packet of convention information and materials and one identified registered delegate for the National Convention. Each additional delegate attending the National Convention will pay a ten dollar (\$10) delegate fee." Post Quartermasters are encouraged to register their delegate on-line through the Online Membership System (OMS). Posts failing to comply with this provision will be considered delinquent and in arrears.

9. Attention of Department Commanders-elect is directed to Section 516, paragraph (b), of the National Bylaws which provides that the Department Commander shall appoint an Adjutant, Inspector, Service Officer and such other officers as may be required by Department Bylaws. The Department Commander may appoint such other officers, committee chairmen and committees as may be necessary to carry out the responsibilities and functions of the Department and the directives of the Commander-in-Chief.

It is recommended that the appointment of the Public Relations officers be based upon the appointee's credentials as a media representative with special emphasis upon qualifications and continuity rather than political criteria.

It is also recommended that consideration be given in the preparation and adoption of Department budgets and to the importance and necessity for providing adequate financial support for Department Public Relations activities.

10. At a meeting on Feb. 28, 2022, the Life Membership Board of Trustees recommended, and the National Council of Administration approved the following 2022-23 Life member payout.

- Plan ABC A total payout of \$10.50 for each Life member (\$3.50 to each Post, Department and National).
- Plan D A total payout of \$16.50 for each Life member (\$5.50 to each Post, Department and National).
- Plan E A total payout of \$27.00 for each Life member (\$9.00 to each Post, Department and National).

As indicated in the Bylaws, payment will be made in Sept. 2022 for all Life members recorded as of Aug. 31, 2022. In addition, a payment will be made in Jan. 2023 for all Life members processed during the period Sept. 1 through Dec. 31 (Plan E) to their Post, Department and to National Headquarters.
